## **APPROVING PERMITTING STANDARD FORMS and TEMPLATES**

WHEREAS the Comfort Lake-Forest Lake Watershed District ("District"), a governmental subdivision with powers set forth in Minnesota Statutes Chapters 103B and 103D, is authorized to act to achieve the purposes set forth in those chapters for the protection, conservation and beneficial use of its water resources;

WHEREAS on December 18, 2008, the District Board of Managers ("Board") adopted Rules under Minnesota Statutes §103D.341 to accomplish the District's statutory purposes, and amended the Rules on February 22, 2018;

WHEREAS to administer its regulatory program, the District uses certain standard forms and templates;

WHEREAS it is appropriate that the Board periodically review and adopt those standard forms and templates, as they may be revised from time to time, to ensure they are consistent with the mandates established by the Board in its Rules; are clear and useful for those subject to District permit requirements; and support the efficient administration of the District's regulatory program.

**THEREFORE BE IT RESOLVED** that the Board approves the following standard forms and templates, which are incorporated as exhibits to this resolution:

- 2. Permit Template
- 3. Notice of Scheduled Site Inspections Form
- 4. Request for Variance and Statement of Hardship Form
- 5. Maintenance Agreement Template
- 6. Maintenance Declaration Template
- 7. Vegetated Buffer Requirements Exhibit
- 8. Stormwater Management Facility Maintenance Schedule Exhibit
- 9. Letter of Credit Template
- 10. Performance Bond Template
- 11. Escrow Agreement Template

**BE IT FURTHER RESOLVED** that the District Administrator shall make these forms available to the public by posting on the District website, and to permit applicants through transmittal of a standard permit application package.

**BE IT FURTHER RESOLVED** that the District Administrator may revise contact information and other non-substantive items on these forms and templates and, on permittee request or otherwise, may adjust template language as in the Administrator's judgment will address the circumstances of a particular permit without materially reducing the water resource protection afforded under the permit.
