Position: Seasonal Technician

The Comfort Lake-Forest Lake Watershed District has an opening for a Seasonal Technician. This is a 40 hours per week full time position within a collaborative office that will last from January to June, 2019. This position will be paid \$15.00 per hour and is not eligible for benefits. The primary focus of this position will be providing support to District staff with regard to the District's permitting program. This may include a variety of primary and cross-functional secondary responsibilities including serving as a permit inspector, reviewing permit application materials, meeting with contractors at construction sites, and overall tracking of permitting program records. This position will also participate in District activities related to watercraft inspections, education and outreach, Best Management Practice cost-share programs, and supporting the District's invasive species monitoring and treatment programs on an as needed basis.
