Subject: Clean Water Partnership Loan B

### Background/Discussion

The purpose of this agenda item is to consider adopting a resolution authorizing execution of a contract amendment to the District's current Clean Water Partnership Loan. This loan is referred to as "Loan B", as the District has already received and closed out one loan in the past; "Loan A."

During the budgeting process, the Board discussed applying for \$3.5 million under Loan B. The MN Pollution Control Agency (MPCA) was only able to approve up to \$1 million when Loan B was executed in December 2021. MPCA suggested the District could apply for loan amendments to receive additional loan dollars. The following summary is adapted from the October 2021 memo. Staff inquired about authorizing an additional \$1 million under the loan, but MPCA has indicated that in an effort to manage cash flow within the program, it can only approve another \$750,000 at this time.

- Loan A: 2018 loan application, now officially closed out.
- Loan B: 2021 loan application, submitted immediately following board adoption of resolution 21-10-01 at the December 16, 2021, board meeting.
  - B1: Initial loan application; \$1 million (entirety has been disbursed)
  - **B2: First loan amendment; \$1 million \$750,000 (current request)**
  - B3: Second loan amendment; \$1 million (potential future request)
  - B4: Third loan amendment; \$500,000 (potential future request)
  - Total Loan B potential award, including amendments = \$3.5 million
- Loan C: This was discussed in 2021 as part of the budget process. A potential future loan application after Loan B is closed out. If Loan B ends up utilizing the total \$3.5 million, this maxes out our current general obligation note, and the District will need to go through the process of obtaining a new note for any subsequent loan applications.

This is retroactive to and amends Resolution 21-12-01 with respect to the Clean Water Partnership Project Implementation Loan Agreement SRF0346.
