
Expenses: \$3.4 million

- 6% levy increase (tax capacity **↑** by 25%)
- Multiple grants and partnerships
- Smart banking to maximize interest revenue
- Clean Water Partnership Loans C & D (debt)



Budget Highlights





- Budget still uncertain, but grants/donations/financing will be sought out
- Gathering public input
- Building workgroup assessing short and long-term options
- Facility tours and board visioning session are occurring
- ISG Needs Assessment to be presented later this year
- Attempt to align with greenway planning





Moody Lake Capstone Project

- Four components:
 - Field Gully Repair
 - Round Barn Soil Excavation
 - Moody Park Improvements
 - South Moody Wetland Dredging
- Phosphorus reduction: 62 lb/yr
- Total suspended solids reduction: 4.5 tons/yr
- Lifetime Project Cost: \$366,800 (~\$400/lb P)
 - CWF Grant: \$239,500
 - CLFLWD Local: \$127,300





WJD-6 Wetland Restoration Project

- Project details
 - Wetland sediment excavation and revegetation
 - Phosphorus loading in system was lower than originally anticipated, and resulting project P reduction is proportionally lower
 - Project is still treating the need in this system
- Phosphorus reduction: 20 lb/yr
- Total suspended solids reduction: 1.6 tons/yr
- Lifetime Project Cost: \$564,000 (~\$1,000/lb P)
 - CWF Grant: \$386,000
 - CLFLWD Local: \$178,000

Impairment Delistings

- Projects and programs serve to improve water quality
- 2010 Six Lakes TMDL included:
 - Moody Lake
 - Bone Lake
 - Comfort Lake
 - Little Comfort Lake
 - Shields Lake
 - School Lake



Bone Lake slated to be removed from impaired waters list in April 2024!

Other five lakes are in line to follow in the next few years

Mixture of programs and projects protect the investment made in the health of our lakes and improve watershed and community resiliency





Resident Stewardship is Vital!

Love your lake? Love your shoreline.

Many of Minnesota's lakes are in trouble. Nearly half of Minnesota's natural shorelines have already been lost, and natural shoreline continues to vanish at an alarming rate.

Mowed shorelines allow 7 to 9 times more pollutants to enter the lake than a more naturally vegetated shoreline. These pollutants accumulate in lakes, often creating serious water quality problems while also promoting algal blooms.

In addition to removing pollutants, Natural shorelines provide valuable habitat for fish and loons, frogs, butterflies, and more.

Protecting and Restoring

In spring of 2023 the CLFLWD launched its new Comprehensive Shoreline Program. This program provides technical and financial resources to lake shore owners looking to restore and protect their shorelines. These resources are outlined below.
