Subject:	2023 Board Meeting Schedule - Amendment



Background/Discussion

The purpose of this agenda item is to consider amending the 2023 Board of Managers regular meeting schedule. The board will need to come to a consensus on two different dates that would ensure a quorum is able to be present at both meetings.

October

Per a request from President Schmaltz, staff have compiled a list of three possible dates to move the October board meeting to. This was requested because multiple board members may not be able to attend the regularly scheduled meeting currently scheduled for Thursday October 26th. All the proposed dates will require contractors, consultants, and staff to finalize meeting materials early.

- 1. RECOMMENDED: Wednesday, October 25th
- 2. Tuesday, October 24th
- 3. Monday, October 23rd

December

It is common practice for the District to hold its November and December regular meetings on the third Thursday of the month. This is normally adequate compensation for holiday schedules. However, the way the days fall this year, the third Thursday of December falls the day before the District observes the Christmas Eve holiday. The District's practice is to approve the bills at the Thursday evening meeting, then sign the checks at the office the next morning. Since the office will be closed that Friday morning, staff proposes rescheduling the December regular board meeting.

- 1. RECOMMENDED: Wednesday, December 20th
- 2. Tuesday, December 19th
- 3. Thursday, December 14th
 - (This will require contractors and consultants to submit their monthly invoices one week earlier.)
