Subject: Curly-Leaf Pondweed Treatment Contract



Background/Discussion

The District's budget includes funds to perform curly-leaf pondweed management on five lakes in 2024 – Moody, Bone, Shields, Forest, and Comfort. Staff sought out proposals from several aquatic invasive species (AIS) treatment firms for curly-leaf pondweed (CLP) this year. We received quotes from just Lake Management Inc. and Limnopro. Of the two quotes, Lake Management Inc. quoted the lower price per acre for Diquat treatment.

Lake Management has performed the District's curly-leaf pondweed treatments for the past several years. The District has never worked with Limnopro and only started requesting treatment quotes from them a few years ago. Each company has a reputation for performing effective control and would be capable of handling the proposed curly-leaf pondweed treatments this year.

Blue Water Science will be performing the curly-leaf delineations over the next few weeks and will send the maps to the District as soon as possible thereafter. Once delineations are complete, they will be submitted to the Department of Natural Resources as part of the permit requirements. As a reminder, Moody Lake is a Natural Environment Lake, therefore Blue Water Science will perform pre and post treatment point intercept surveys to remain compliant with the DNR's variance permit.

Staff recommends that the Board authorize the Administrator to execute a service agreement with Lake Management Inc. for the treatment of curly-leaf pondweed on Forest Lake, which is likely to exceed \$20,000. Curly-leaf pondweed treatments for Moody, Bone, Shields, and Comfort Lakes will not exceed \$20,000 and are within the administrator's contracting authority.
